

5. **OBJECTS OF THE TRUST :**

1. To create unity, brotherhood etc. through public awareness. To render and support all kinds of social, educational services irrespective of race, colour, religious convictions or cultural grouping including the opening and running of educational institutions such as pre-schools, primary and secondary schools, which may include boarding facilities, colleges, universities etc., libraries, cultural centres, sport facilities and provide scholarships for deserving blind person.
2. To run economic projects and investments with purpose of supporting the aims and objectives of this Trust.
3. To Work for the welfare of the General Public through various Programmes, lectures, demonstration, publication and other activities.
4. To promote ecological balance.
5. To help the poor / needy and intelligent blind students and to spread education in the society at large. Special emphasis has been laid on the welfare of Backward & women.
6. To adopt any running educational Institution(s) already working and giving education to the society at large, to uplift the standard and to help management its financially as well as educationally
7. To generally carry on all activities such as educational / charitable, as may be decided by the Managing Committee of the Trust from time to time.
8. To prevent and manage environmental diseases, environmental upkit.
9. To provide free notebooks, free textbooks, free uniforms, school fees, tuition fees, grant scholarship and prizes and/or loans of financial assistance in any manner to deserving students.
10. To establish, maintain and support Institutions, libraries, reading rooms containing cultural books, halls, hostels, lodging and boarding houses, canteens, auditoriums and structures for any of the objects and purposes of this Trust.
11. The Trust shall pay particular attention to educate, start training camps and community development work in rural areas.
12. To Trust shall grant scholarships, stipends and other monetary assistance to persons engaged in activities which promote its objectives and to provide animal birth control for stray dogs and shelters for sick or injured stray animals.

13. To Trust shall establish, funds, construct, maintain and assist in the promotion of institutions for the scientific, technological, agricultural, industrial and economic progress and development of the country and carry out research in various fields of humanities development in Urban and in rural areas.
14. To construct Hospital, guidance Centers, Clinics etc.
15. To establish, maintain and support or grant or give monetary assistance and medical relief to hospitals, dispensaries, nursing homes, maternity homes, medical clinics, family asylums, institutions with facilities for the free boarding and lodging, convalescent homes, orphanages, homes for widows or destitute women, child welfare activities, paediatric care and/or to contribute to any Trust or institution established for the same purpose or any one or more of them.
16. To organize conference, CME Programmers, Seminars, workshops, Symposiums & updates on environment and environmental diseases.
17. To advice to construct Eco-friendly houses.
18. To encourage medical education, arrange medical seminars, seminars for cancer patients, medial help to cancer patients, physical fitness education workshops and conferences for specific disease, medical research and family planning.
19. To establish, promote, run, maintain, assist, finance, set up Social and cultural Ceremony Hall, Sanatoriums and Dharmashalas, throughout India.
20. To organize, cultural programs and other social / functional gatherings like to celebrate festivals and auspicious days like National festival & to Birth & Death Anniversary of Leaders of the Nation.
21. To encourage sports including setting up of Stadiums, Health Clubs, Gymkhanas, Sports Complex and all other activities incidental thereto.
22. To give Scholarships, free ships, charitable help and render other kind of aid to students including supply of books stipends, medals and other incentives, educational help and in cash or kind to the needy and deserving students without making distinction of case and creed. To establish, develop, maintain and grant aid in cash or in kind to hospitals, medical schools, colleges, nursing institutions in India for the benefit and use of the general public.
23. To teach the school children, prepare books, handbills, booklets, on Environment environmental diseases.
24. To establish one or more clinic and shelters for all kinds of animals if required.
25. To spread awareness of and provide educational materials for brining awareness on the plight and care of stray animals and to enhance public health by providing services for stray animals.
26. To undertake propaganda, training and education of the masses either on our own or in co-operation with similar agencies working for a similar cause and to acquire and maintain the movable and immovable properties for achieving said objects by taking proper permission of authorized person or department.

27. To establish, maintain or grant aid to homes for aged, orphanages or other establishments for the relief and help to the poor, need and destitute people, orphans, widows and aged persons.
28. To conduct competition, to promote environmental awareness, to select Brand Ambassadors to promote.
29. To organize events for the promotion of healthy environment and other activities of healthcare & environment care.
30. To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help. To arrange Health / medical camp. To provide Ambulance Services to the poor peoples. To give Medical Assistance to poor and needy people without any caste or creed. To give financial aid to poor and needy peoples.
31. To mass education of public.
32. To implement various schemes for rural farmers, needy villages and provide training to them.
33. To implement various Govt. and Local Bodies Schemes for SC ST & OBC.
34. To implement various schemes of State & Central Govt. Municipal Bodies, Local Bodies.
35. To work in co-ordination with other organizations, NGO'S & Govt. Bodies.
36. To implement all other Social, Educational, Industrial Cultural, Religious etc. schemes whichever trustees feel to implement for social benefits.
37. To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, etc and to give donations and other assistance to institutions, establishments or persons engages in such relief work.
38. To do such other things which are incidental conducive to attainment of above objects.
